# About our key-note speaker

#### Professor John McMillan AO - Acting NSW Ombudsman

Professor McMillan was appointed Acting NSW Ombudsman for a two year term commencing in August 2015. He was previously the inaugural Australian Information Commissioner (2010-15), Commonwealth Ombudsman (2003-2010) and the Integrity Commissioner (Acting) for the Australian Commission for Law Enforcement Integrity (2007).

John is an Emeritus Professor at the Australian National University, where he taught administrative and constitutional law from 1983-2003. He has been a solicitor in private practice, a legal consultant to many parliamentary and governmental inquiries, and was active in public interest advocacy in promoting open government reform. He is a co-author of a leading student text, Control of Government Action: Text, Cases and Commentary (2015, 4th ed).

John is a National Fellow of the Institute of Public Administration Australia, a Fellow of the Australian Academy of Law, and former President of the Australian Institute of Administrative Law.

John was made an Officer of the Order of Australia (AO) in the Australia Day Honours List 2010 for his work as Ombudsman, academic and in professional societies.

# **About our panelists**

#### Cathrin Cassarchis - State Archivist and Executive Director State Records Office of Western Australia

Cathrin Cassarchis is State Archivist and Executive Director, State Records Office of Western Australia. The State Records Office (**SRO**) is responsible for the administration of the *State Records Act 2000* which regulates whole-of-government recordkeeping. It supports the State Records Commission in the development of a regulatory framework for implementation of this Act, as well as providing consultancy, advice and training to State and local government organisations on best practice. SRO also controls the State Archives Collection, providing access to government departments, and public access to unrestricted archives to the wider community.

Cathrin was appointed to the position in March 2008 after returning to Australia in 2002 and taking up a position at the Western Australian Museum Foundation. She has previously worked for The National Archives in the United Kingdom and prior to that for the National Council on Archives (UK). Cathrin is Executive Secretary to the State Records Commission and a member of the Council of Australasian Archives and Records Authorities. She is also a Council member of the Institute of Public Administration WA.

#### Giles Nunis, Chief Executive and Government CIO Office of the Government Chief Information Officer

Giles Nunis was appointed into the inaugural role of Chief Executive and Government Chief Information Officer on 28 April 2015, and established the new GCIO office on 1 July 2015.

Giles was the Deputy Director General at the Department of State Development since early 2010. He was responsible for negotiating commercial State Agreements on behalf of the government with

major resource companies and managing the government's international trade offices. During this time Giles was also seconded to the Department of Health and played a major role in restructuring of the department's Fiona Stanley Hospital ICT Program which was successfully delivered on time for the opening of the hospital in November 2014.

Prior to joining the WA Government, Giles was the National Managing Director of a multi-national ICT and Management Consulting firm, based in Melbourne, with its head office in Zurich, Switzerland. With more than 600 consultants nationally he was responsible for managing a \$150M business.

Giles has undertaken a number of major ICT consulting assignments in Australia, SE Asia and the UK in both the government and private sector in the following industries: health; licensing; compliance & regulation; courts; legal; banking; land tenure; and hospitality.

# Lynsey Warbey, Commissioner's Counsel, Office of the Commissioner, Western Australia Police

Lynsey Warbey is a career public servant and lawyer who has worked in the WA and Victorian Public Sector for nearly two decades. Lynsey has had broad experience from working on Royal Commissions to running large commercial litigation. Materially, Lynsey led the WA State Solicitor's Information Practice for a number of years and maintains an active practice in freedom of information and other aspects of public information confidentiality and disclosure. Lynsey is currently Legal Counsel to the WA Police Commissioner, on secondment from the State Solicitor's Office, and is passionate about the public sector's responsibilities for the information it holds.

## Damien Hassan, Senior Archivist, State Records Office of WA

Damien Hassan is a Senior Archivist at the State Records Office of WA (**SRO**) where he has worked for many years across different areas of the office. He has also worked in policy and project roles at the Department of the Premier and Cabinet and the WA Museum. Damien is currently managing several large scale digitisation and systems development projects for the SRO.

Shane has worked as an Organiser and Student Development Officer for the Association of Professional Engineers, Scientists and Managers Australia where he was involved in contract negotiation, workplace dispute resolution and lecturing on Industrial Relations and Job Seeking. Shane is currently a Freedom of Information Coordinator with the Department of the Premier and Cabinet, where he has worked for the last six years. Shane is responsible for processing FOI applications made to the Department, the Office of the Premier and all WA Ministers as well as providing FOI briefings, education and advice to all Ministerial and Departmental staff.

## Megan Ashford, State Solicitor's Office

Megan Ashford commenced articles at the State Solicitor's Office in 2007 and practices within the Office's specialist advising team. A large portion of her practice is in relation to access to information matters and she presently supervises the Office's 'FOI Team'.
